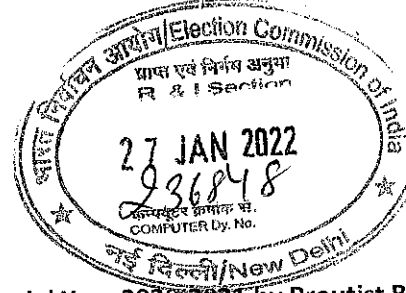

Your kind attention is invited to Letter dated 11 September 2010 bearing number F. No. 56/203/2009/PPS-I, issued to the subject party (i.e. Proutist Bloc, India) granting registration under Section 29A of the Representation of People Act, 1951. According to said approval letter 'Proutist Bloc, India' (hereinafter 'PBI') has been granted registration under the status of unrecognized political party with effect from 07-September-2010.

As per requirement of Section 29C of the Representation of People Act, 1951 and as contained in the para 4 of the aforementioned approval letter, PBI is required to file/submit to the Commission, a report of contribution received in excess of Rs.20,000/- in a financial year from a person. Further, as prescribed under Rule 85B of the 'Conduct of Elections Rules, 1961', said report is required to be furnished in Form 24A.

The contribution of Rs 50,000 was received in our account on 28.09.2020 through a mob no 9319347475 which is not responding despite our best efforts. I had requested our Bank—SBI, Malviya Nagar branch, New Delhi—to find out the address and PAN of the remitter. They could only give us the mob. no. 9319347475, dated 28.09.2020 by which money was transferred.

As stated earlier, we had called several times without any response. We enclose here the request letter to the bank dated 11.1.2022 and their comments at the back of the same letter.

In compliance with aforesaid provision, PBI hereby submits a NIL report in Form 24A annexed herewith for Financial Year 2020-21 for your kind perusal and records. Kindly acknowledge the receipt of the same.

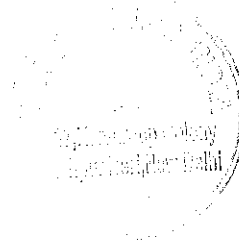

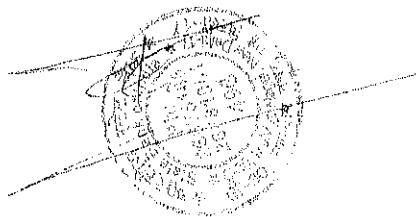
