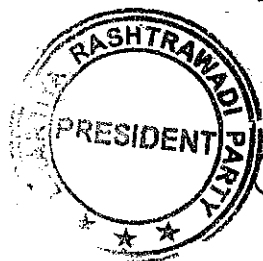
3. Auditor's Responsibility
