Management's Responsibility for the Financial Statements

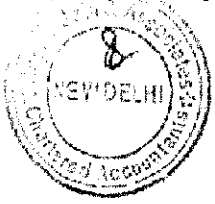

SIGNIFICANT ACCOUNTING POLICIES AND NOTES ON ACCOUNTS

a) **Basis of Preparation**

The Financial Statements are prepared under the historical cost convention on accrual basis and in accordance with the generally accepted accounting principles and the applicable Accounting Standards issued by the Institute of Chartered Accountants of India.

b) **Use of Estimates**

The preparation of financial statements is in conformity with the generally accepted accounting principles which require the Management to make estimates and assumptions that affect the reported amounts of assets and liabilities on the date of financial statements. Actual results if they differ from those estimates are recognized in the current and future accounting periods.

c) **Revenue Recognition**

Except annual membership fee from members all income are recognized on accrual basis.

d) **Fixed Assets and Depreciation**

Fixed assets are stated at historical cost less accumulated depreciation. The depreciation is provided as per the written down value method for the full year irrespective of the date of purchase.

e) **Investments**

All investments are long term and stated at cost. Provision for diminution if any in the value of investments, other than temporary, is made in the accounts.

f) **Employee Benefits**

Remuneration and other employee benefits payable are accounted for on accrual basis.

g) **Provisions, contingent liabilities**

The party creates a provision when there is a present obligation as a result of a past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may but probably will not require an outflow of resources. Disclosure is also made in respect of a present obligation that probably requires an outflow of resources, where it is not possible to make a reliable estimate of the related outflow. Where there is a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.
